Enter this date on the empty line below the return address of the landlord marked "Date." It can be the date of the landlord's signature, a date before the signature or the date on which the document was drawn up. Do not indicate a date later than the expected date of signature in this line. The area immediately following the greeting ("To Who Concerns This May") will consist of a statement with a few blank lines. Use the first blank line of this declaration to formally document the full name of the owner signing the form. The first name, surname and surname of the person (Subject) whose address is validated by this form must be entered in the second blank space of the declaration. The physical address of residence of the subject of this form must be indicated in the next blank space. This act must take place in front of two witnesses and a notary. A blank line under the word "Best regards" was provided for the landlord to sign. The second page of this document will provide the areas needed for witness entities to verify the landlord's signature to the testimony contained. Before starting this process, make sure to enter the full name of the owner in the first blank line here. Two separate areas have been included (starting with the labels "Witness #1" and "Witness #2" respectively) so that each Witness can meet the requirements of this section. First, the Witness must sign the Witness signature line. the one indicated as "Witness #1" of "Witness #2." After signing his name, each Witness who signed it must print it on the Name line. The blank line labeled "Data" in each of these testimony areas will require the date of signature when the witness has signed his or her registered name.
