When an employee receives a reimbursement from his employer for the business expenses incurred (i.e. airfare, meals or lodging), the reimbursement payment technically constitutes the gross income to the employee. However, a reimbursed employee business expense may be excluded from gross income if it is made in accordance with a "schedule of accounts" according to which the employer requires the employee to justify all expenses and reimburse any amounts received in excess of the documented expenses. (IRS Treasury Regulation 1.62-2 (c)). In order to qualify as a "plan of accounts", the following tests must be met: for operating expenses incurred by the employee in connection with the performance of his duties; the plan must require that: To justify their own costs within a reasonable period of time (see below for a definition of â € œreasonableâ €); And the plan must request employees to reimburse any refunds that exceed the costs incurred within a reasonable period of time (see below for a definition of â € œreasonableâ €). If these tests are not satisfied, the entire amount of the reimbursement should be included in the income of the employee (even if the employee can have the right to compensate for this income by deducting the expenses on his tax returning). (IRS Treasury Rules 1.62-2 (c) (5)). The determination of a reasonable period of time will depend on the facts and circumstances. The IRS has defined the guidelines with point 2 and 3 above for â € œThe reasonable time periodâ € . In the Treasury Regulation of IRS 1.62-2 (G) (2), IRS has established "secure ports" that can be used to guarantee reasonableness. These secure ports claim that based on a fixed date, an advance carried out within 30 days from the moment a charge is paid or supported, a spending justified to the payer within 60 days after it is paid or sustained, or an amount returned to Payer within 120 days after an expense is paid or incurred will be treated as a reasonable period of time. For the system reimbursement policy (see budget office and guidelines for accounting funds), meal reimbursements are not necessary to be justified. Meals are reimbursed for actual expenses incurred up to a maximum for DIEM. The IRS allows employees to qualify as part of a responsible level when the IRS tables for Diem are used. Definition: A refund is a monetary compensation received to cover a transaction made previously. In other words, it means retrieving money from a given purchase. What does the rebound in business? Some situations for reimbursement could be: travel expenses that a company reimburses to an employee, an insurance company reimburses for a drug purchased from an insured individual or a purchase made for someone else that must be refunded. Let's take a look at this example for further illustration. Example Mr. Coleman is the National Sales Manager of Caribbean Coffee Co. a company that produces coffee for the retail market. As part of his regular duties he must travel to many different cities within the United States to supervise the Regional Sales Managers. The company normally pays Mr. Coleman's travel expenses upfront but this time he had a trip last time and there Wasna t enough time to issue the payment to cover his expenses. Mr. Coleman collected all the receipts for these expenses and gave them to the company. Is this a refund situation? The repayment term, according to our definition, is a monetary compensation received in return for a transaction previously made. Such travel expenses should have been covered by the company. This means that the company must reimburse all expenses incurred by Mr. Coleman during the trip, according to the company's refund policies.
