A reference list is placed at the end of your paper. It contains the full details of all the references cited in the text of your paper. These details should be sufficient for the reader to be able to identify and locate the sources. The reference list should be organised in alphabetical order by the author's family name. All in-text references should be listed in the reference list at the end of your document. The purpose of the reference list entry is to contain all the information that a reader of your work needs to follow-up on your sources. An important principle in referencing is to be consistent. When compiling your APA Reference List, you should: List references on a new page with a centred heading titled: References. Include all your references, regardless of format, e.g. books, journal articles, online sources, in one alphabetical listing from A - Z. Order entries alphabetically by surname of author(s). List works with no author under the first significant word of the title. Indent second and subsequent lines of each entry (5-7 spaces). Use double spacing. Note that all references in APA end with a full stop except when the reference ends with a URL or a DOI. APA Style has an excellent worksheet that takes you through how to formulate various Reference List entries: Below are examples of a Journal article and Book formats. Refer to individual format pages for further examples, and the Sample Reference List page for an example of a Reference list. Journal article A basic reference list entry for a journal article in APA must include: Author or authors. The surnames followed by first initials. Year of publication of the article (in round brackets). Article title. Journal title (in italics). Volume of journal (in italics). Issue of journal (no italics). Page range of article. DOI (presented as a hyperlink, for example . The first line of each citation is left adjusted. Every subsequent line is indented 5-7 spaces. Example: Ruxton, C. (2016). Tea: Hydration and other health benefits. *Primary Health Care*, 26(8), 34-42. Book A basic reference list entry for a book from a library database in APA must include: Author or authors. The surnames followed by first initials. Year of publication of the book (in round brackets). Book title (in italics). Edition (in round brackets), if other than first edition. Publisher. DOI (where a book has a DOI this must be included, even if you are referring to a print book). The first line of each citation is left adjusted. Every subsequent line is indented 5-7 spaces. Example: Morley, C., Ablett, P., & Macfarlane, S. (2019). *Engaging with social work: A critical introduction* (2nd ed.). Cambridge University Press. No specific font type or size required. Recommendations include Calibrize 11, Arial size 11, Lucida size 10, Times New Roman size 12, Georgia size 11 or Computer Modern size 10 (LaTeX). The last name of the author(s) and the year of publication are generally needed. They can be included within parentheses or brackets (parenthetical) eg. (Thompson, 2018), or part of a sentence (narrative) eg. Thompson (2018) has argued that "...". In rare cases, the author and date might both appear in the narrative. In this case, do not use parentheses eg. In 2018, Thomson argued that. ... They can appear within a sentence or at the end of a sentence before the full stop eg. this week (Johns, 2017). A page number is included for a direct quote. Place a comma after the year and use p. for single page, pp. for multiple pages eg. (Harris, 2012, p. 164) or (Lewis, 2016, pp. 56-58). When you paraphrase or refer to an idea from another work, a page number is not required. However, it can be useful to include. If there is no date, the abbreviation n.d. may be used eg. (Harris, n.d.) If work is not yet published, use in press. (Taylor, in press). Separate multiple references within the same reference with a semicolon. g. (Jones, 2021; Keiston, 2019; Ellory & Harris, 2023) Appendices contain matter that belongs with your paper, rather than in it. For example, an appendix might contain the survey questions or scales you used for your research, detailed description of data that was referred to in your paper, long lists that are too unwieldy to be given in the paper, correspondence received from the company you are analysing, copies of documents being discussed (if required), etc. You may be asked to include certain details or documents in appendices, or you may choose to use an appendix to illustrate details that would be inappropriate or distracting in the body of your text, but are still worth presenting to the readers of your paper. Each topic should have its own appendix. For example, if you have a survey that you gave to participants and an assessment tool which was used to analyse the results of that survey, they should be in different appendices. However, if you are including a number of responses to that survey, do not put each response in a separate appendix, but group them together in one appendix as they belong together. How do you format an appendix? Appendices go at the very end of your paper, after your reference list. (If you are using footnotes, tables or figures, then the end of your paper will follow this pattern: reference list, footnotes, tables, figures, appendices). Each appendix starts on a separate page. If you have only one appendix, it is simply labelled "Appendix". If you have more than one, they are given letters: "Appendix A", "Appendix B", "Appendix C", etc. The label for your appendix (which is just "Appendix" or "Appendix A" - do not put anything else with it), like your reference list, is placed at the top of the page, centered and in bold, beginning with a capital letter. You then give a title for your appendix, centered and in bold, on the next line. Use title case for the appendix label and title. The first paragraph of your appendix is not indented (it is flush with the left margin), but all other paragraphs follow the normal pattern of indenting the first line. Use double line spacing, just like you would for the body of your paper. How do I refer to my appendices in my paper? In your paper, when you mention information that will be included or expanded upon in your appendices, you refer to the appendix by its label and capitalise the letters that are capitalised in the label: Questions in the survey were designed to illicit reflective responses (see Appendix A). As the consent form in Appendix B illustrates... How do I use references in my appendices? Appendices are considered to be part of your paper for the purpose of referencing. Any in-text citations used in your appendix should be formatted exactly the same way you would format it in the body of your paper, and the references cited in your appendices will go in your reference list (they do not go in a special section of your reference list, but are treated like normal references). If you have included reproduced matter in your appendices, treat them like an image or a table that has been copied or adapted. Place the information for the source in the notes under the reproduced matter (a full copyright acknowledgement for theses or works being published, or the shorter version used at JCU for assignments), and put the reference in the reference list. Quotes / Paraphrasing Quotes are text that is repeated or copied from text written by another person, with the exact same wording, punctuation and spelling. Double quotation marks must be used. The author, year and page number (if provided) must be cited. The page number can be placed at the end of the quote, as in the image below. Paraphrasing is when you use your own words to express someone else's ideas, or to summarise their research. When paraphrasing, you do not need to include the page number; however it is encouraged, as it assists others to find the information that is referenced. Brief or longer quotes Brief quotes are less than 40 words. Refer to Quotes above for format. Longer quotes are 40 words or more. Format as a block quote, as explained below: Do not use quotation marks. Start the quote on a new line. Indent the block quote about half an inch on the left margin. Cite the source at the end of the quote, after the final punctuation mark. If the author was cited in the sentence before the quote, then only reference the page or paragraph at the end. Example of a longer quote: The study by Preston and Logan (2014) showed that this is the quote here. It started in lowercase because it is continuing on from the sentence above. The quote goes for at least 40 words. The paragraph can continue after this block quote; just continue with the text aligned on the left margin, in line with the sentence that introduced this quote.
